
Market closed red 12-Sep-2019


### DSEX DOWN 79.12 POINTS

DSEX continued its bearish trend this week as weakening confidence on financial sector and legal battle between BRTC and GP triggered massive sell pressure in the market. Broad Index, DSEX, dropped by 1.58% or 79.12 points over the week and closed on 4,933.89 points. Market P/E (x) dropped to 12.71. Among large caps, GP increased by 2.9% while BATBC dropped by 4.6%. Most of the sectors faced correction expect telecommunication which gained 3.0%. The continuous drop in the market might continue until important issues like NPL issue in the banking sector, increased borrowing by the government and GP/BTRC tussle settles down.


# Intraweek Performance of DSEX
