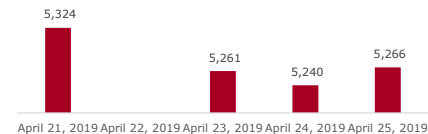


DSEX DOWN 55.23 POINTS

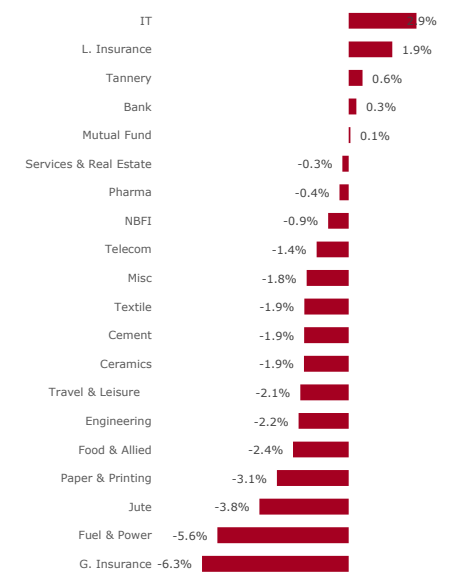
With three red and one green sessions, market closed in red this week. DSEX dropped 55.23 points (1.04%) to close at 5,266.18. Average turnover in this week experienced 10.8% gained compared to previous week.

Most of the major sectors closed in red. FORTUNE topped the turnover chart and gained 7.5% over the week. UPGDCL remained in the turnover chart for the third consecutive week but posted 14.3% loss. Telecom giant GP declared its first-quarter earnings of 2019 - EPS grew 39.5% YoY to BDT 6.61 during 1Q2019. Despite impressive growth in the earnings, the scrip lost 1.14% over the week as the tussle between GP and Government over unpaid claims continues.

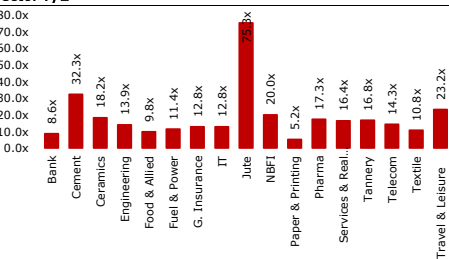
Intraweek Performance of DSEX



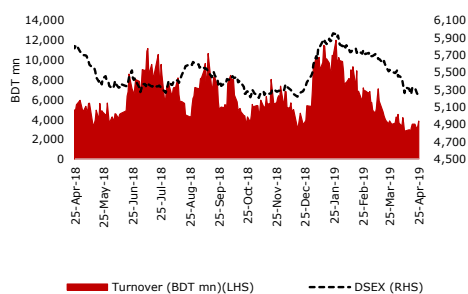
Sector Return
